Registration Contract (Must be signed and completed upon registration)
Please initial that you have read all policies and procedures. We require a signature on the back of this form.

Payment of Fees:

Tuition can be paid by

- Cash
- Check payable to Ballroom With Us
- Credit/Debit Cards (We accept Visa, MasterCard, American Express and Discover)

If you do not choose the auto-pay option, you will be pre-billed by e-mail (if provided) 15 days before your next payment due date. This is as a courtesy reminder. Please mark your calendar to avoid late fees.

All tuition is priced annually for a 10month dance season (September to June). You have your choice of 3 billing options: Annual, Quarterly or Monthly. There is no "price per class." All classes, regardless of the day of the week they are held on will receive the same amount of classes by years end. If you choose the Monthly payment option, please understand, Monthly installments have no reflection on the amount of classes held during that month, as there are only 9 payments for a 10month season. Late registration may be pro-rated.

Please indicate your preferred billing method: 1 Annual payment, due by September 1st, or upon registration, with a 5% discount
3 Quarterly payments, due September 15 th , December 15 th , and March 15 th
9 Monthly payments, due on the 15 th of each month September to May

Regardless of billing preference, a one-month installment is due to hold your spot in any class upon registration. A 10% interest rate is automatically incurred for all past due payments for tuition. To help avoid these fees, we offer automatic credit card processing and check handling. Returned check fees are \$30 per check. All uncollected fees will be turned over to a collections agency and incur a 30% collections fee.

Withdrawals and Refunds:

If you wish to withdraw from a class at any time, a withdrawal slip must be completed by the parent or guardian. Phone messages or emails will not be accepted as proof of withdrawal. Withdrawals must be done at the front desk and not with a teacher. If you have chosen to participate in the recital, your withdrawal deadline is April 1st after which all refunds are forfeited. To withdraw from classes a parent or adult student must:

- 1. Inform studio office staff.
- 2. Complete and sign a withdrawal form provided by the school office.

You will be held accountable for tuition charged to your account until the date that the withdrawal form is received by our office, regardless of classes attended/not attended prior to that date. Pre-paid tuition for classes held after the date of the withdrawal (before April 1st) will be refunded. Your registration fee is non-refundable. No refunds will be given for dancewear, exchanges only.

Recital Costumes:

Costume fees are due November 15th. Participation in our recital is not required, however once payments are made, no refunds are available, whether you choose to participate in the recital or not. Costumes will not be ordered until fees are paid in full. Costumes cannot be exchanged or refunded. Alterations are not usually necessary; however, should you require alterations, they are not included in the price of the costume. Costumes include required tights. All Level Classes: \$85.00

Dress Code:

A class specific dress code will be specified to you upon confirmation of registration and class schedule. The required dance attire and footwear must be worn to all classes. Failure to wear required dancewear to class will result in student being asked to sit out the class. Repeated failure to follow dress code will result in termination of lessons. Please do not allow students to wear the dance shoes outside of the studio.

Attendance and Lateness:

All absences should be called in to the office. Any student who misses their regular class is permitted to take a make-up at another class during the week. Make-up classes need to be scheduled in advance with the front desk. Missed classes can be made up at any time throughout the season. Any student, who arrives late to class, after the warm-up portion of the class (approximately the first 10-15 minutes), will not be permitted to participate and will be asked to observe instead. A minimum attendance standard will be required. Students missing more than 10 classes after January 1st will not be allowed to participate in the recital. In such a case, no refunds will be given for costume deposits or balances, however a full tuition refund for the remaining pre-paid classes will be granted.

INITIAL HERE:

Care of Students:

The school is not responsible for providing before or after class care for students or their siblings. Students are not to be left at school for excessive time periods before or after their classes. Siblings must be in the care of a parent at all times. Please know that in the case of a fire or other emergency, our staff will only be accountable for students participating in a class and recorded in the roll book. Young students should be escorted to and from the building.
